Stabling: **Limited** stabling available at nearby farms—some with B&B available. \$35/night; 1 bag shavings provided. Additional bags available for \$7/bag--must pre-order. \$25 Muck Fee (separate check) must accompany entry. **If you wish to have stabling—enter early!**

Dressage: Arena and warm-up: grass; sand-based turf. Tests: T-USEF 2018; Training Test A-Sm; N-USEF 2018 Novice Test A-Sm.; BN-USEF 2018 Beginner Novice Test A-Sm.; MDN-USDF 2019 Intro Test C-Sm.; GAG-USDF 2019 Intro Test A-Sm.

Cross Country/SJ: T-up to 3'3" @450mpm; N-2'11" @ 400mpm; BN-2'7" @350mpm; MDN-up to 2'3" @300mpm; GAG-18"-2' @250mpm. Rolling, sand-based turf, all-weather footing. Inviting and varied obstacles on hilly terrain, good for schooling—BN, N, and T courses have questions 'up to their level'. Water optional at Maiden and GaG. ALL XC WILL BE TIMED. Show Jumping on fairly level, sand-based turf.

Other Information: Trailer parking (Moor Meadow) approx. Open XC Schooling Day—February 17th. **Do not send Schooling Day Entry with Horse Trial Entry!!!** See website for information. No wheeled vehicles on XC. All dogs MUST be leashed—\$100 fine.

Directions: Driving South on Hwy 1: pass under Vass Exit, go to Aiken Rd (1.8 mi—across from Exxon station) turn left; go 1.6 miles to Furr Rd; turn right; go 1.2 miles, and turn left onto sand road; follow RSHT signs to Moor Meadow and parking. Driving North on Hwy 1: Approx 5 miles north of Southern Pines, turn right onto Youngs Rd; go just over .6 miles, and turn left onto Furr Rd; go 1.4 miles, and turn right onto sand road; follow RSHT signs to Moor Meadow and parking.

Do NOT use Lakebay Rd entrance!
